2020 HAWAI'I REGION OVERVIEW & HIGHLIGHTS

The Hawai'i Region includes four volunteer-based Chapters (Kaua'i, O'ahu, Maui, and Kona) that are part of the worldwide Surfrider Foundation network based in San Clemente. California. Chapter programs and campaigns focus on five initiatives: Plastic Pollution, Ocean Protection, Clean Water, Beach Access, and Coastal Preservation. In 2020, Regional efforts centered supporting cross-chapter collaboration and strengthening statewide presence. Despite the many challenges of 2020, the Hawai'i Chapters actively to engage their local communities in protecting the ocean, waves, and beaches of Hawai'i.

2020 Highlights

- Won four major campaign victories, including local single-use plastic bans and a clean water win at the U.S. Supreme Court.
- Launched statewide outreach related to plastic pollution.
- Joined Global Ghost Gear Initiative to address derelict fishing gear.
- Increased focus on Environmental Justice, Diversity, and Equity.
- Welcomed Lauren Blickley as the new Hawai'i Regional Manager.

Surfrider Foundation is a non-profit, grassroots organization dedicated to the protection and enjoyment of the world's ocean, waves, and beaches, for all people, through a powerful activist network.

PROGRAMS

Surfrider Foundation achieves its mission through five programs. These programs help focus our work, not only in Hawai'i but across the Nation. Individual chapters incorporate programs according to the immediate needs and opportunities present in their communities.











Blue Water Task Force (BWTF) labs are active on Kaua'i, O'ahu, and Maui. Volunteers test local beaches for fecal indicator bacteria levels and compare them to water quality standards set to protect public health.

The Ocean Friendly Restaurants program promotes plastic reduction and sustainable practices throughout the restaurant industry.

Rise Above Plastics raises awareness about the dangers of plastic pollution. Surfrider Foundation Chapters have been instrumental in passing single-use plastic bans across Hawai'i.

Beach cleanups and Net Patrols are a staple of Hawai'i Chapters and remove over a hundred thousand pounds of rubbish off Hawai'i shorelines every year.



The Ocean Friendly Gardens program sees yards and landscapes as solutions to water pollution.

REGIONAL Programs & Events

Chapters within the Hawai'i Region work together to support regional programs, events, and educational campaigns.



ENVIRONMENTAL JUSTICE

As part of Surfrider Foundation's increased focus on Justice, Diversity, Equity, and Inclusion, the O'ahu Chapter helped organize a statewide Environmental Justice Panel Series. The Chapters also regionally screened the documentary "White Wash" followed by a panel discussion with producer Airrion Copeland and professional longboarder Nique Miller.

COVID-19 PPE AWARENESS CAMPAIGN

The COVID-19 pandemic introduced a new source of plastic pollution -Personal Protective Equipment (PPE) that includes masks and gloves. Led by the Kaua'i Chapter, the Hawai'i Region launched a statewide "PPE Awareness Campaign" to educate the public about proper disposal and the importance of reusable PPE.

"CHOOSE TO REUSE" OUTREACH CAMPAIGN

The O'ahu Chapter helped launch a statewide outreach campaign to educate on the safety and importance of reusables. The campaign promotes five steps that restaurants can take to reduce unnecessary waste and save money.

ACTIVE CAMPAIGNS

Campaigns are how Surfrider Foundation measures and tracks our efforts. We define campaigns as a yes/no decision by a governing body or agency. In 2020, Hawai'i Chapters maintained 11 active campagins.

CAMPAIGN Victories

In 2020, Surfrider Foundation Hawai'i Chapters won **four** major campaign victories in the areas of plastic pollution and water quality.

MAUI BILL 52: BANS SINGLE-USE PLASTIC FOODWARE

KAUA'I BILL 2775: BANS POLYSTYRENE TO-GO CONTAINERS

REGIONAL: EPA ACCOUNTS FOR PLASTIC POLLUTION UNDER CLEAN WATER ACT

Led by the Kaua'i Chapter, Surfrider Foundation sued the Hawai'i Department of Health (HDOH) for failing to take into account plastic pollution when evaluating impaired waters under the Clean Water Act. The U.S. EPA ruled in favor of Surfrider Foundation and required the HDOH to re-evaluate its list of impaired waters, taking into account plastic pollution.

FEDERAL: SUPREME COURT DEFENDS THE CLEAN WATER ACT

In a critical decision, the U.S. Supreme Court upheld the Clean Water Act and determined that Maui's wastewater injection wells violated the federal law by pumping millions of gallons of treated sewage into the ocean each day.

The Kaua'i Chapter is a powerhouse when it comes to fighting for clean water and addressing plastic pollution. In addition to maintaining small group beach cleanups and continuous water quality monitoring, the Chapter also hosted ocean-based educational programs for students, passed an islandwide styrofoam ban, and launched the Ocean Friendly Visitor awareness program.

PRIORITY: COASTAL PRESERVATION

- Develop community-based recommendations to address chronic erosion and beach loss
- Increase statewide, public awareness about coastal erosion & sea level rise

HAWAI'I CHAPTER NETWORK

- More fully integrate environmental justice and diversity into Surfrider Foundation programs, campaigns, and leadership
- Strengthen statewide Chapter network and leadership teams
